Board President (Wallace) called meeting to order at 6:33 p.m.

Approval of Previous Meeting Minutes – 9/9/19 general member meeting.

Wallace proposed approval of the September minutes. Alexander motioned to accept the minutes. Peitsch seconded the motion. Motion passed.

BOARD REPORTS

Directors Report (Saldana)

- Five band members made area jazz band. This is the most of any district band and a school record.
- October is a full month with band activities.
 - Next week is very busy with FB Band Night, homecoming parade and pep rally.
 - Homecoming game is on Saturday Alumni will be able to sit with the band in 3rd and 4th quarter.
 - o Contest later this month.
 - MS Band night preparation is in the works.
- Band will not be doing garters for the band, but band can wear their own mum or garter.
- A request was made for purchase of a replacement speaker system. It is not worthwhile to repair the current system. The proposal is a starter speaker system from Julie Romero Music for about \$2000 total to replace the old PA system. An alternate option would be a more expensive higher-quality system, but it is not expandable. The funds would come from the excess dining card money.
 - A motion was made to pay an amount not to exceed \$2,100 to Romeo Music for the proposed Mipro speaker system with transmitter and microphone as shown on the

agenda handout.

Alexander motioned to approve. Wolf seconded. The motion was approved.

- A request was made for an overage of about \$205 (\$2,200 total, but budgeted at \$2,000) for licensing of the Respighi and Copeland music this year. Mr. Saldana also requests to include a higher amount in the budget for next year.
 - A motion was made to pay \$2,205 (\$205 over the budgeted amount of \$2000) to Tresona Music Licensing payment for licensing of the Respighi and Copeland music.
 Peitsch motioned to approve. Shah seconded. The motion was approved.

President Report (Wallace)

 <u>UIL</u> – UIL contest will be October 22nd at Hall Stadium, with an Oct 23rd rain out date. We will need help with various jobs.

Vice President (Alexander)

- Pizza Sales Sales are going great. We are topping out around 200 pizzas, similar to last year.
- Senior pinning Senior pinning is coming up on November 8th. We need someone to take over for next year since Mary's son is graduating. We also need a replacement announcer since Dave Steinke will also be on the field. Monica Ray will check with her husband.

Treasurers Report (Shah)

- Financial Review
 - Financial statements as of August 2019 were reviewed.
 - Only 2 overdue amounts are outstanding.
 - We filled an extension for our tax return due to a software problem from the CPA. We have 6 additional months to file. This year we had to complete the 990 instead of the 990EZ due to higher income.

Merchandise – There were good merchandise sales at the last game. Merchandise sales will also happen at Hall and Mercer games – 10/11 (Homecoming), 10/17, 10/25; Fall and Winter merchandise is coming as well.

Fundraising – There are 2 dinner nights are coming: MOD Pizza on 11/7/19 and Papa Murphy's on 12/12/19. Dates will be added to Charms. We received funds from Chipotle and MOD pizza night.
