# **Call to Order (Prezas)**

- Called meeting to order at 6:35 pm.
- Approval of minutes from September meeting. Shanda Guillory-McClure Motioned. Monica Ray Seconded. Minutes were approved.

## **BOARD REPORTS**

## Directors Report (Saldaña/Burson/Baños)—

- Lone Star Preview went well.
- All flags have arrived, and the prop vinyls are being shipped rush and will arrive in 3 days. Credit for changed order will be used to pay for rush shipping charge.
  - Late delivery caused by a couple of factors. First, timing of using District funds and only having one approved vendor; can start using District funds for upcoming school year no sooner than first week after July 4<sup>th</sup> Holiday. And second, the vendor has an employee shortage and equipment problems in one of their factories thus delaying all orders.
  - Next year recommend using booster funds and order in April. There are no vendor constraints if booster funds are used.

- o Consider paying summer staff with district funds instead of booster funds.
- Use district funds for paying for next year's show in the winter / spring.
- Consider adding new vendors, however if an existing vendor misses the deadline to renew their bid, they cannot be an approved vendor for 5 years.
- Consider using other companies not specifically focused on marching bands.

## President (Prezas)—

- E-Motions—Executive board members need to respond to E-motions in a timelier manner. Will send a text when email approval is required. Need all cell numbers of board members since not all are posted on website.
- Trunk-or-Treat—proposing Friday, October 29 after practice. Will set up a Sign-up Genius to go out in this weekend's newsletter. Plan for candy donations to be turned in by Tuesday, October 26.
- End of marching season/semester fun activity for students. Consider lock-in or other activity separate from the banquet. Past banquets have included lock-in afterwards. Mr. Saldaña would like to move to more traditional banquet/awards event in the Spring. Splitting the event is ideal. Perhaps on November 12 or 13 based on playoff game date. Need to determine what will be done for the party at school vs. offsite location such as indoor trampoline
- Podium skirts, approx. \$300 each- would like to purchase. Will explore vendors and overall pricing with band logo
- Breast Cancer Awareness plumes for 2022 season? Approx. \$10/plume consider adding to budget for next year

- Plans for trailer lift gate—end of marching season vs football season. Mr. Saldaña recommends moving forward after football season is over.
- Plans to possibly purchase smaller trailer in lieu of using box trucks next year. Analyze cost of renting versus buying. Also consider difficulty in getting rental trucks and drivers. Considering approximately 20' trailer that can be pulled by a pickup or SUV.
- Current vacancy: Assistant Treasurer; will begin this week to recruit for this position. Currently, Parliamentarian and President have been covering duties of the Assistant Treasurer. As a last resort, if a volunteer is not found, consider splitting the responsibility into two positions.
  - Per Bylaws, Article VII, Section 4 "Should a vacancy occur in any other office, the President shall have the power to forthwith fill the vacancy by appointment and the person appointed should assume the title and duties of said office for the remainder of the term in which the vacancy occurs. Such action shall be read into the minutes of the regular meeting."

    - Total Sales \$20,183.50

    - Net Profit \$10,351.50
